## **TIMELINE**

- STEP 1** SIGNATURE OF THE **LEGAL SERVICES AGREEMENT** WITH **DESJARDINS LAWYERS** **CAN\$10 000**
- OPENING OF YOUR FILE AND START OF THE PROCESS
- STEP 2** YOUR **EXPRESSION OF INTEREST** IS READY TO BE FILED TO THE PROVINCE **CAN\$5 000**
- STEP 3** RECEPTION OF YOUR **INVITATION TO APPLY** **ii) CAN\$10 000 + ii) CAN\$7 500 payable to the third party verifier**
- STEP 4** ISSUANCE OF **THE LETTER OF SUPPORT** BY THE PROVINCE **CAN\$10 000**
- STEP 5** FILING OF YOUR **BUSINESS WORK PERMIT APPLICATION** TO THE FEDERAL GOVERNMENT (IRCC)
- STEP 6** ISSUANCE OF YOUR **BUSINESS WORK PERMIT ARRIVAL** IN CANADA TO START YOUR BUSINESS

**TIMELINE FOR STEP #1 TO STEP #6: 12 TO 15 MONTHS**

- STEP 7** AT LEAST **6 TO 12 MONTHS OF BUSINESS OPERATIONS** WITH INVESTMENT OF AT LEAST CAN\$150 000

**STEP 8** SUBMISSION OF YOUR REQUEST FOR **NOMINATION** TO THE PROVINCE **CAN\$10 000**

**STEP 9** FILING OF YOUR PERMANENT RESIDENCY ("PR") VISA APPLICATION TO IRCC **CAN\$5 000**

**STEP 10** OBTAINING YOUR PR VISA

**TIMELINE FOR STEP #7 TO STEP #10: 12 TO 15 MONTHS**

**TOTAL COST: FROM CAN\$207 500**

*Government processing fees are excluded (approx. \$4000 per family, depending on the number of family members).*

# ELIGIBILITY CRITERIA (SUMMARY)

---

## **A. Profile:**

- i) Have a Net Worth of CAN\$500 000+ (US\$365 350);
- ii) Have 2 years+ of Experience as a business owner or 5 years+ of senior management experience within the past 5 years;
- iii) Proficiency in English equivalent to Canadian Language Benchmarks (CLB) 4/10;
- iv) Have at least the equivalent of a Canadian High School diploma;
- v) Must be aged between 21 to 59 years old.

## **B. Business commitments:**

- i) Complete an Exploratory visit to the Province;
- ii) Provide active and on-going management of the business for at least 6 to 12 months;
- iii) Make a minimum of investment of at least CAN\$150 000;
- iv) Create at least 1 new full-time job for a Canadian Citizen or Permanent Resident;
- v) Plan to live in the Province.
